The Ultimate Fighting Championships (UFC) just sold for an unprecedented \$4 Billion dollars, marking it as one of the largest sales in sports history. Floyd Mayweather and Manny Pacquiao, professionals in UFC are cognized as two of the highest paid athletes in all of sports. Both sports have gritty exteriors, but they are not without the legal and regulatory issues developing at this time. This panel will discuss how the Muhammad Ali Boxing Reform Act, enacted in 2006, has affected boxing and its potential effectiveness or ineffectiveness in Mixed Martial Arts (MMA) with the proposed expansion of the current regulations. The panel will also discuss the class action antitrust lawsuit against the Ultimate Fighting Championship (UFC) and the logistics of representing athletes within the industry.
