This year's symposium will explore the legal and policy implications of the costs facing south Floridians as they work to protect their homes and environmental support system from global warming, sea level rise, pollution, degradation and congestion. Skyrocketing housing costs, gentrification, higher construction, building and infrastructure relocation or retrofitting, and insurance costs, and the loss of ecosystem services are just a few of the major economic and social issues facing south Floridians. Tort liability and financial sanctions arising from public advocacy and legal challenges about these issues are another.

The symposium will explore the legal and policy implications, and mechanisms available or needed to ensure that all south Floridians can continue to afford to live in south Florida and use their constitutional and legal rights to protect their homes, quality of life and future.
