

### **Donor Opportunity Overview for the Technology and Innovation Program at NSU Law**

As an institutional contributor to the Technology and Innovation program at Nova Southeastern University Shepard Broad College of Law (NSU Law”), your contribution enables us to bring essential and timely training to students, staff. These efforts help ensure that NSU Law graduates are able to take advantage of the newest tools available in the legal marketplace, to use those tools ethically and confidently, and to provide leadership on the future of the practice of law for their employers.

Your investment in NSU Law will support the efforts during this academic year (through June 30, 2026). We seek annual donors to support the education, training, and outreach. As an example, the following activities have already occurred or been scheduled:

#### **Faculty Trainings on Managing Artificial Intelligence in Instruction and Evaluation**

- This August, we offered panels featuring **Jon Garon, Jane Cross, Oscar Fernandez, Keith Rizzardi, Steven Tepple, and Michael Epstein** designed to explore academic policies and hands-on exercises on how to best develop AI skills for students while ensuring academic integrity. The session included examples of in-class exercises for faculty to use with students.
- Additional programs for faculty will be held in Winter term and each semester thereafter.

#### **Student Immersive Training**

- **NSU-NSLT Advanced Legal Technology Certificate**, Dec. 10-11, 2025. This 16-hour program is the first of its kind for law schools, combining an anticipated 8 hours of in-class training and an additional 8 hours of online, module-based training offered for law students in all of NSU Law’s degree programs as well as attorneys seeking CLE credit. Upon completion, students will be awarded a certificate by the **National Society for Legal Technology**. Topics will include the fundamentals of legal technology, generative artificial intelligence, e-discovery, digital forensics, cybersecurity, online evidence protection, trade secret protection, and compliance with ethical standards and the Rules of Professional Responsibility. Faculty and CLE hour availability TBD.
- **Digital Wellness and Cyber Health Program (for NSU Law Students), Cybersecurity Month.** The Digital Wellness and CyberHealth Awareness event is designed to help students take full advantage of online resources while protecting themselves from unwanted interactions and intrusions. This event provides valuable insights into best practices to manage one’s online activities, understand personal cybersecurity, and provide tools to promote well-being and reduce the risk of attacks.

#### **Additional Student-Centered Activities**

- The Program is working with **NSU's H. Wayne Huizenga College of Business and Entrepreneurship** to develop simulation modules in conjunction with a virtual reality and artificial intelligence development company. These modules aim to build interactive, immersive learning experiences for law students, business students, and students across all disciplines at NSU.
- The law school has launched “Law Practice Business and Technology,” a 2-credit workshop providing hands-on experience for students to learn how to evaluate, adopt, and use legal technology to improve client outcomes and law firm success.

- The Program has sponsored NSU Law's first competition teams for the MiLA AI Student competition.

### **CLE Programming**

The Technology and Innovation program offers regular CLE activities with both annual events and one-time projects. Here are upcoming examples:

- **Nana & Papa Go High Tech, Legal & Technology Strategies for Older Adults, November 5, 2025, 6:00-9:30 p.m.** This comprehensive program examines the intersection of technology and elder law, covering emerging issues from digital wellness tools to sophisticated fraud schemes targeting seniors. Practitioners will gain practical knowledge about advising clients on technology adoption, protecting their interests in digital transactions, and planning for the digital aspects of their estates. The program addresses both the benefits technology can provide to aging clients and the legal pitfalls that must be avoided, offering concrete strategies for counseling older adults and their families through technology-related decisions. Speakers include **John Isaza, Adam Goldberg, Marilyn Uzdavines, Julie Agris, Jon Garon**, and many more.
- **Sharon & Mitchell Berger, Annual Berger Business Boot Camp, Nov. 12-13, 2025.** In partnership with the **Sharon & Mitchell Berger Entrepreneurial Law Clinic** led by **Steven Kass**, the Technology and Innovation program is extending the outreach to the broader community. Increasingly, we have added issues of customer data, cybersecurity, and compliance obligations to intellectual property fundamentals and business basics for one of the most comprehensive two-day training courses available anywhere.
- Collaboration with the **Jay A. Ziskind Health Law Lecture Series**. Now in its sixth year, the lecture series has provided exceptional education on health law activities. Both last year and this year, the focus has included artificial intelligence. This program is led by Professor Uzdavines and generously supported through a grant from Jay A. Ziskind. This year's lecture will feature Dr. Meenesh Bhimani, M.D., MHA Co-Founder and Chief Medical Officer of Hippocratic AI along with Dean Jon M. Garon.
