

**Winter 2021 Exams 48 Hours Windows**

Please note: Reading Period runs April 16 through April 19, 2021. Exams windows begin on Tuesday April 20 and run through Friday May 7th. All exam windows are open from midnight on the first date listed to 11:59 pm on the second date listed and close to student access at that time. Within that window, any exams with a time limit shorter than 48 hours, once opened by a student, runs continuously for that time period and may not be saved for reopening at a later time. Exams that are designated as 48-hour exams are available to students at any time throughout the window. The specific length of each exam will be provided closer to the exam period.
