

NCAA PAY TO PLAY ACT

This panel brings madness in March as attorneys discuss the NCAA's new proposition to allow athletes to profit off their names, images, and likeness "in a manner consistent with the collegiate model". They will also be discussing how states like California and Florida pressured the NCAA to reach this resolution with new rules slated to go in effect Jan. 2021. With this ruling, the NCAA has opened the door to a plethora of concerns students and schools will confront, such as diversity inclusion and gender equality, and whether schools will follow blanket rules of compensation.
