- The DIAL Clinic was the only fully interdisciplinary cross-disability civil rights clinic in Florida. I lead the Clinic's litigation, policy initiatives, community partnerships, and statewide advocacy while supervising between twenty and twenty-five students annually in federal and state trials, appeals, Individuals with Disabilities Education Act (IDEA) hearings, administrative hearings, and systemic civil rights matters involving the Americans with Disabilities Act (ADA), the Fair Housing Act (FHA), and the Rehabilitation Act (RA).
- The Clinic operated as a full-service civil rights practice with students conducting interviews, preparing litigation strategy, drafting complaints, participating in negotiations, and engaging in appellate work. My role included designing and delivering a curriculum grounded in trauma-informed advocacy, reflective practice, disability justice principles, and the American Bar Association's emphasis on professional identity formation. I integrated these components with live-client representation, guest speakers, simulation-based training, and early lawyering responsibility.
- The DIAL Clinic operated as a full civil-rights law firm where students assume meaningful responsibility under close faculty supervision. Students develop litigation skills, engage in professional identity formation, and work directly with clients from multiply marginalized communities. Students participate in all portions of a case's lifecycle, from demand letters, administrative complaints, discovery and motion practice, negotiation and settlement, class action litigation, trial and appellate proceedings.

- Students handled more than one hundred fifty guardianship and supported decision-making matters each year, preparing petitions, advising families on legal alternatives, conducting accessibility-based negotiations, and advocating for autonomy-centered supports.

Classes Taught

- **DIAL Clinic** – The DIAL Clinic included a two-hour weekly course and two hours of clinical rounds where the clinic gathered to discuss case elements and strategies.
- **Civil Rights Litigation Seminar** (Fall 2024 and Fall 2025) – upper-level writing requirement seminar that examined litigation under 42 USC 1983 from a litigation point of view. Included guest lecturers who are leaders in the civil rights bar.

EXPERIENTIAL EDUCATION LEADERSHIP

Annual Family Café

- From 2023 to 2025, The DIAL Clinic attended the Family Café, the largest cross-disability event in Florida for families with children that have disabilities I organized and delivered impactful workshops on guardianship alternatives, fair housing rights, and inclusive communication, while creating the Independent Living Kitchen to provide practical guidance on essential legal documents during the conference. These initiatives not only educated thousands of attendees but also offered law students hands-on experience in client interaction and advocacy under real-world conditions. Additionally, I managed event logistics, budgeting, and community engagement, reinforcing the clinic's visibility and commitment to disability rights advocacy.

Summer Internship Program

- In the Summer of "Make an Impact in Law and Medicine" Summer Internship at the DIAL Clinic was a six-week interdisciplinary program bringing together law students, medical students, and high school scholars to explore the intersection of disability rights, healthcare, and civil law. Designed to foster mentorship and professional development, the internship combined classroom instruction, courtroom observation, and independent research projects focused on disability advocacy and effective communication in healthcare. As Law Clinic Director, I led program coordination, delivered lectures on civil rights and disability law, and supervised student research.

Inclusive Communications and Technology Day

- On October 25, 2024, NSU hosted the Inclusive Communications and Technology Day, a hybrid event designed to advance accessibility and inclusion through technology. The program featured sessions on assistive tools such as speech-to-text, text-to-speech, captioning, and emerging applications of generative AI for individuals with cognitive, sensory, and developmental disabilities. I organized and led the event, shaping its agenda to highlight universal design principles and practical strategies for integrating AI into accessibility solutions.

Guardian Advocacy Workshops

- From 2022 to the Winter of 2025, the DIAL Clinic hosted Guardian Advocacy Workshops each semester to assist families of adults with developmental disabilities to plan the least restrictive form of support required.. These events provide free legal guidance, reduce waitlists, and empower participants through one-on-one consultations. Supported by law students, attorneys, and community volunteers, workshops address immediate legal needs and promote advocacy skills.

Simulation for Providing Effective Communication to a Deaf Patient during Labor and Delivery

- As part of an interdisciplinary training initiative, I designed and facilitated a high-impact simulation addressing communication barriers in healthcare for individuals with disabilities. The scenario centered on a deaf woman in active labor arriving at a hospital requiring effective accommodations to demonstrate best practices required under the ADA and RA, particularly regarding informed consent and patient autonomy. In my role as lead legal educator, I am collaborating with medical faculty and simulation faculty to integrate legal standards into clinical practice. This initiative provides participants with experiential learning at the intersection of law and medicine, reinforcing the critical role of proactive accommodations and cultural competence in healthcare delivery.

Since 1998, I have led a coordinated effort to ensure the inclusion of lawyers and other people with disabilities to be seen and accommodated by the Florida Bar

- In 2004, the Disability Independence Group coordinated a bar-wide survey on lawyers with disabilities, producing actionable data that informed policy changes and enhanced inclusion within the Bar.
- Advocated modification Florida Bar rules by eliminating discriminatory mental health inquiries for bar applicants, ensuring equitable admission standards.
- Authored Florida Rule of Judicial Procedure 2.540, mandating ADA accommodations across all Florida courts to protect the rights of persons with disabilities.
- Chaired the Equal Opportunity, Animal Law, and Public Interest Law Sections of The Florida Bar, leading initiatives that advanced diversity and inclusion.
- Strengthened legal education and bar readiness through active service on the Student Education and Admission to the Bar Committee (SEABC), collaborating with Florida law schools.
- Founded the Puppy Pit wellness initiative as Chair of the Animal Law Section, promoting mental health and well-being for attorneys and law students statewide.
