Advanced Legal Research Techniques

- Prepare and deliver lectures and interactive instruction for Advanced Legal Research Techniques course (in person, synchronous, and asynchronous formats).

RESEARCH AND REFERENCE LIBRARIAN

Research and Reference - Provide faculty, students, staff, alumni, and community patrons with research assistance and help locating legal resources including one-on-one research consultations. Record research and reference interaction details for annual library reports and to build a shared and evolving library knowledge base using Gimlet application. Provide reference desk assistance (in person and via Zoom).

Interlibrary Loan - Manage interlibrary loan systems including borrowing, lending, copyright clearance, licensing, supply orders and staff training. Prepare statistical reports regarding volume of borrowing and lending data.

Library Guides - Create and maintain library research guides on Springshare LibGuides platform.

Marketing and Collection Development - Market library services, resources, and databases through: classroom instruction, displays, brochures, library guides, and other outreach programs. Suggest new materials for the library collection to the Collection Development Committee.

Faculty Outreach - Serve as library liaison for twelve full time faculty, adjunct faculty, online and graduate programs, and visiting faculty informing them of library services and resources, facilitating and assisting with their professional research, and distributing database passwords. Assist faculty with submission of their scholarship using Scholastica, ExpressO, and SSRN.

Student Outreach - Provide research training and support and serve as liaison to multiple student extracurricular organizations including: Nova Law Review, ILSA Journal of International and Comparative Law, and Moot Court Society. Serve as liaison to NSU Law Online and Graduate Program (Master's and LLM) faculty and students providing them with an introduction to library services and databases during orientation and ongoing research support throughout their program. Create video introductions of study guide databases and other library resources for students. Provide library tours to prospective and current students. Coach NSU Law alumni who are preparing for the Florida bar exam as part of Academic Success and Professionalism Program's Raising the Bar program since 2017.
