LOCATING A CASE BY CITATION

If you have a citation to a case, you can simply:

- pull the book off of the shelf if you are using print;
- use the Get a Document command on Lexis; or
- use the *Find command* on *Westlaw*.

A citation contains the following information:

- **names of the parties** involved with the lawsuit;
- the **volume of the reporter** in which the decision is located;
- the **name of the reporter** in which the decision is located;
- the **page number of the reporter** on which the case can be found;
- the court that issued the decision; and
- the **year** in which the decision was issued.
