ACADEMIC SUCCESS AND PROFESSIONALISM

midst the transition to online learning, the Academic Success and Professionalism program (ASP) team has continued its focus to assist all NSU law students develop a solid foundation for success as they study for the bar exam. Each graduate is assigned an expert bar coach, either an ASP Professor of Practice or an NSU Law faculty member, who provides individualized support, counseling, and mentoring during bar preparation in the summer for the July bar exam and in the winter for the February bar exam. The program works with and supplements each student's commercial bar preparation course, offering additional opportunities to develop and practice the skills and content knowledge required for success on the bar exam and offering support and community during the months leading up to the bar exam. The ASP team's expertise in online learning means that we can support our students whether they are studying in the building or remotely.

EMERGENCY RELIEF FUND

The wellbeing of students at NSU Law is always our utmost priority. The administration recently secured a \$25,000 grant from the AccessLex Institute to provide financial relief to currently-enrolled students during this global crisis. While these funds are vital, we need your help to make a greater impact.

NSU Law is asking alumni, friends, and supporters to match the \$25,000 grant from the AccessLex Institute, so we can further provide emergency financial assistance to students in need, as well as assist recent graduates who are otherwise ineligible for the AccessLex Institute funds while they prepare for their Bar examinations. The generous grant from AccessLex Institute only provides assistance to current students, but NSU Law has many students close to graduation who have reached out to our administration with financial concerns, having incurred sudden expenses including the loss of a job, food insecurities, or other emergency-related costs. A scholarship application for the NSU Law Emergency Relief Fund has been created for students to express their emergency needs. A faculty and administrative committee has been established to review these applications.

NSU LAW RANKED NATIONALLY BY U. S. NEWS & WORLD REPORT



SU Shepard Broad College of Law continues to grow its reputation in our JD program through its standing in the *U.S. News & World Report.* Overall, our Part-Time Law program is now ranked in the top 50 Law Schools nationwide, reflecting the many student-centered changes we've enacted throughout our program, and our commitment to ensuring access to legal education.

In the specialty ranking areas, our reputation has continued to grow among our peers. Across the board, nearly all our programs demonstrated upward movement in their rankings, including our new Intellectual Property concentration and our live client experiential education clinic program. This year, we were particularly recognized in three areas. Our Legal Research and Writing program is once again ranked 2nd in Florida moving up two spots to be ranked 18th nationally by U.S. News & World Report. We have long recognized Legal Research and Writing (LRW) as a point of pride for NSU Law. Under the direction of Dean Olympia Duhart, the program has gained national prominence as the faculty in the program take on leadership positions in national organizations, publish significant books and articles, and help NSU's law students be practice ready for their clerkships and internships. The LRW Student Outreach program was also recognized this year for its significant effort, with the Florida Bar Group Professionalism award, whose purpose is to recognize an organization (such as a bar association, judicial organization, inn of court, or law school organization) that has enhanced professionalism among lawyers and students through innovative programs that can be implemented by other organizations to promote and encourage professionalism across the legal community.

The NSU Law Health Law program has been ranked (tied) 1st in Florida and moved up two spots to be ranked 54th nationally. Under the leadership of Professors Kathy Cerminara and Marilyn Uzdavines, NSU Law has expanded its interprofessional partnerships with the Dr. Kiran C. Patel College of Allopathic Medicine, the Dr. Kiran C. Patel College of Osteopathic Medicine, and many of the other colleges and programs throughout NSU's Health Professions Division. The Health Law program once again was the focus of the annual Law Review symposium, as well as hosting other programs for the community, increasing its national reputation for scholarship and innovation in the field. Combined with a wide-ranging curriculum and active involvement by many of the NSU Law fulltime and adjunct faculty, including longtime supporter and adjunct professor Gerald Morris (NSU 1977), this program will continue to be a leader in health law education as the field faces new challenges. The Health Law program at NSU offers a diverse and varied curriculum for students to become health law practitioners and policy makers.

This year, for the first-time our Trial Advocacy Program moved up more than 50 spots in the *U.S. News and World Report* specialty rankings, to be ranked 50th in the country. Encompassing a broad range of foundational, simulation, and live-client experiential courses, our curriculum, taught by an experienced and energetic team of full-time and adjunct faculty members is just the beginning for our students engaged in this program. The vast opportunities for co-curricular opportunities through competition teams, and extra-curricular opportunities such as our Trial Advocacy Summer Institute (TASI), ensure that students can continue to grow their skill level in innovative and exciting ways. Our vast network of alumni volunteers have contributed immeasurably to our students' success, and we thank you and encourage you to get involved with our programs.

A key measure of our University is the strength of our community and connections. The focus that our faculty places on student success is a result of the teaching, scholarship, and broad interdisciplinary engagement of the NSU Law faculty, staff and NSU leadership. "Our faculty have developed exemplary national programs in these important, practice ready specialties," said Debra Vollweiler, Interim Dean of the law school. "This allows us to remain truly student-centered ensuring our students' future success in their chosen fields."

LEGAL RESEARCH AND WRITING (LRW) STUDENT OUTREACH PROGRAM

The LRW Student Outreach Committee is a special volunteer working group of LRW Faculty designed to target first-year law students by reinforcing legal research and writing skills with a concentration on professionalism. Since 2013, the program has provided an opportunity for NSU Law Students to focus on writing and wellness, citation, oral advocacy, interviewing, time management, ethics and legal networking with local lawyers and judges. Each year, the program offers highly interactive workshops. It

also allows upper-level students opportunities for "near peer" mentoring with the 1Ls. The LRW Student Outreach Committee is comprised of LRW Faculty committed to the discipline of LRW and student-centered instruction. Professor Joe Hnylka is the current Chair of the LRW Student Outreach Committee. Associate Dean Olympia Duhart is the Director of the NSU Law Legal Research & Writing Program.

FACULTY SPOTLIGHT

he NSU Shepard Broad Law Center, as it was then known, opened its doors to students in 1974 and graduated its first class of attorneys in 1977. Professor of Law Michael Richmond walked through those doors in 1978 and in May 2020 will "figuratively" walk through the doors for the last time as an honored and well-loved faculty member. Professor Richmond will retire officially on June 30, 2020 and we plan to honor his legacy properly once we are all able to gather together again.

Countless alumni attended his Torts classes through the years as well as his Constitutional Law II class, Law and Literature Seminar, and coached Moot Court teams, among his many educational connections. When asked why he chose to focus on Tort Law, Professor Richmond's response was, "Torts is just plain fun!" One of his favorite classes included the case, *In re Polemis* that dealt with an explosion in Casablanca harbor during World War I. Professor Richmond provided a memorable experience briefing the case himself, dressed as Humphrey Bogart: fedora, trench coat, cigarette dangling from his lip, and the character's trademark accent. Another memory Professor Richmond shared was his annual "competition" with Professor Michael Flynn to see which Torts class could donate the greatest number of cans during the annual "canned immunity" food drive. The real winners were the Broward residents who could put food on their tables for Thanksgiving.

After 42 years with NSU and NSU Shepard Broad College of Law, Professor Richmond has won numerous awards, served on countless committees and has published a wealth of scholarly literature of which he is justifiably proud. He leaves the following wisdom for his fellow faculty and staff, and to his students; "Be lawyers, not attorneys. Have more than the mind of an attorney. Embrace the heart of a lawyer. Care for your clients and care for the Law." To his students in particular, "You will always be my students and I look forward to the pleasure of learning about your careers and lives."

Yineth Sanchez Aslan graduated from NSU Law in the spring of 2016 and continues to fulfill her goals of advocating for victims. She also continues to promote the need for diversity and inclusion of underrepresented minorities in the law.

Among the many reasons that NSU Law has earned a U.S. News and World Report specialty ranking in Trial Advocacy is the Trial Advocacy Summer Institute (TASI). Yineth, along with the NSU Trial Association leadership team and faculty advisors, organized the first TASI program in August 2015. The institute is a platform specifically designed for intensive learning of basic trial skills unconnected to any coursework. Each year, TASI continues to connect excited and eager law students with top trial attorneys and judges from Miami-Dade, West Palm Beach, and Broward counties. TASI provides an intimate environment where the instructors can nurture and shape the raw talent of the students, transforming that talent into measurable skill. As of 2020, more than 400 students and more than 200 alumni and attorney trial instructors have participated in the program.

As a member of the board of directors of the Broward County Hispanic Bar Association (BCHBA), in January 2020 Yineth and the BCHBA board founded the first Broward County Bilingual High School Conference, Our Bilingual Journey: The Challenges and Benefits of Bilingualism in the Legal Profession. In a partnership with the Broward County Public Schools and BCHBA, 125 students and panelists gathered for a full day of large and small group discussions. Attorneys, judges, and Spanish-speaking high school students shared their bilingual experiences, the benefits and challenges of growing up in a bilingual home, the effects of bilingualism in the legal profession, and how

to use bilingual skills to excel professionally. Yineth and the BCHBA team are looking forward to the 2021 conference. "The passion and determination to overcome the challenge of a language barrier are remarkable proof of the resilient spirit of immigrants. My hope is that other groups and organizations will recognize that and in turn create more opportunities for success for this bilingual population."
