Starting a Legal Master's Program – Gaining Support

- Champion for the program
 - Dean must be on board
- Strong program coordinator/director
- Faculty
- Law School Administration
 - Registrar, Financial Aid, Marketing, IT, etc.

- Main Campus
 - Provost, Graduate Program
 Administration, Registrar,
 Financial Aid, Marketing, IT, etc.
- Admissions
 - Recruiters vs local vs partner program

Starting a Legal Master's Program – Early Decisions & Conversations

- Existing campus program or brand new program
 - Leverage the reputation of a Center/Institute or a distinguished faculty in a topical area
- Topical area or generic
- Define program outcomes
- Online, campus, or hybrid
 - Asynchronous, synchronous, or asynchronous with synchronous component
 - Required immersion weekend(s)
 - Online is ok
 - Working with a partner

Starting a Legal Master's Program – Early Decisions & Conversations Continued

- Accreditation
 - Regional accreditors
 - ABA acquiescence
 - Title IV funding
 - SARA (State Authorization Reciprocity Agreement)
- University approvals Law School, President, Board of Trustees
- Academic calendar
- Academic policies

Starting a Legal Master's Program – Challenges

- Being a Graduate Program within a Law School
- Educating the market on a program that people aren't familiar with
 - MLS, MSL, MSCJ, MJ, etc.
 - Degree program for non-lawyers
- Negative social media comments
 - Bar exam
 - Cost

 - Grading and feedback

Starting a Legal Master's Program – Online Curriculum

- Working with other online programs on campus
- Asynchronous vs synchronous
 - Curriculum development vs teaching
 - Pre-recorded lectures
 - Range of options for different budgets and skill-sets
- Working with an instructional designer
 - Faculty are subject matter experts
 - Instructional designers help translate traditional campus teaching into the online environment
